ii. Policy Review:

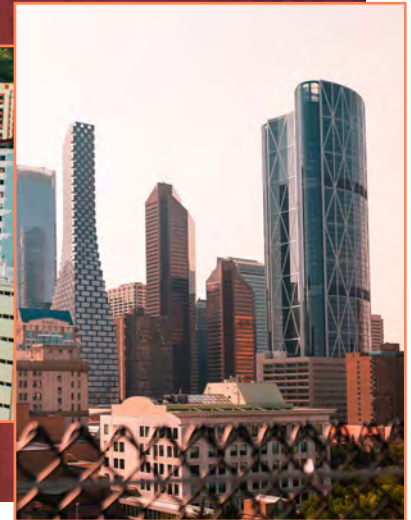
We would apply our global experience on reviewing existing policies, benchmarked against global standards by providing a checklist that would assist cedants to align its policies in line with emerging trends.

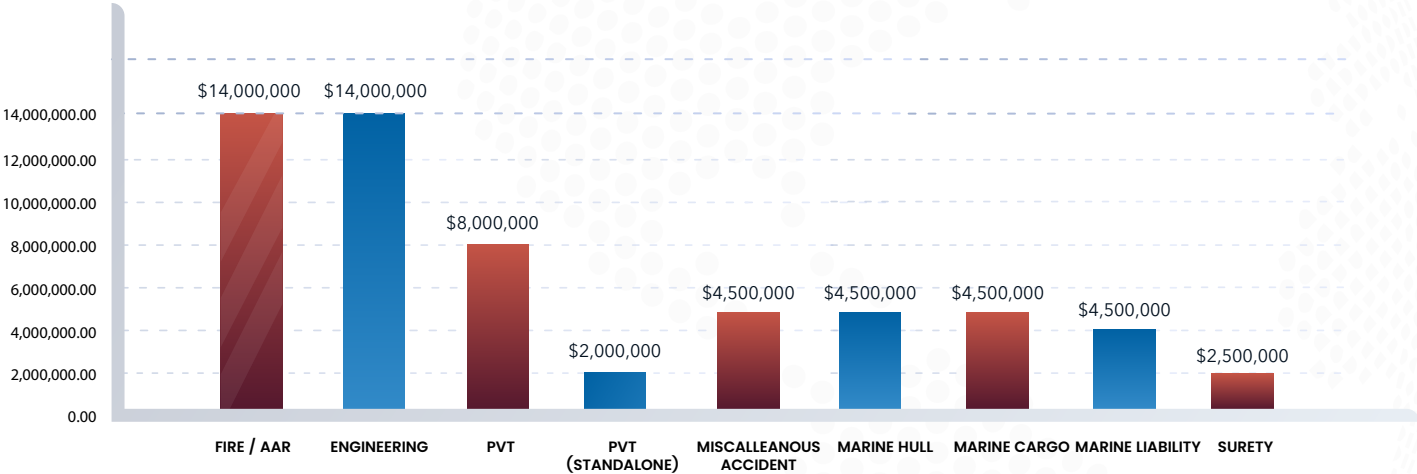
